### Advising/Registration for Fall 2020 (Previous Semester)

MAR 30 – APR 10 Mandatory Advising for continuing students

APR 13 – 24 Early Registration for Fall 2020

JUN 29 Unit Cap increased from 17 to 19 units. Beginning Monday, 12 a.m. (early morning) you can register for additional units, up to 19.

JUN 29 Release reserve capacity seats (lower division GE classes)

### AUGUST 2020

MON AUG 10 Deadline – Pay fall 2020 registration **TUITION & FEES** if initially registered between April 13 and August 10. A hold will be placed on the student's account. (See Student Financial Services.)

SUN-THU AUG 16-20 Orientation

SUN AUG 23 Deadline: **TERM WITHDRAWAL (full refund)** – Last day to withdraw from fall semester and receive a full refund of fees. After this date, students will be charged prorated fees for each day that has elapsed from the first day of the term. See Withdrawal Process.

MON AUG 24 **INSTRUCTION BEGINS** (Online only instruction for the first 2 weeks of classes.)

FRI AUG 28 Deadline – Last day to **WAIT LIST** classes

SAT AUG 29 Last day to be automatically enrolled from wait list

SUN AUG 30 Deadline – Last day to **ADD** open courses without permission numbers

### SEPTEMBER 2020

MON SEP 7 LABOR DAY HOLIDAY — *Campus Closed*

MON SEP 7 Deadline – Last day to file **EDUCATIONAL LEAVE** for Fall 2020

MON SEP 7 ON-TIME Application Deadline – Last day to file an application for Advancement to Candidacy & Graduation (master's students) for spring 2021 **graduation**.

MON SEP 7 ON-TIME Application Deadline – Last day to apply for summer or fall 2021 **GRADUATION** (bachelor's degree)

MON SEP 7 Student Center: Apply for Graduation deadline: Last day to apply for fall 2020 graduation through Student Center (bachelor's degree). Applying after this date requires a Late Application for Graduation e-form.

TUE SEP 8 **FACE-TO-FACE INSTRUCTION** begins for classes with an on-campus component.

MON SEP 14 Deadline – Last day to **ADD** courses (using a permission number)

MON SEP 14 Deadline – Last day to **DROP** courses through Student Center. [After this date, courses cannot be dropped; a request for permission to withdraw with a documented serious and compelling reason will be required. A grade of "W" will be recorded for each course.]

MON SEP 14 Deadline – Last day to **DROP ALL** courses (term withdrawal) through Student Center. Eligible for a prorated refund. [After this date, courses cannot be dropped; a request for permission to withdraw with a documented serious and compelling reason will be required. A grade of "W" will be recorded for each course.]

MON SEP 14 Financial Aid Deadline – Final date to set your enrollment for financial aid disbursement. See "**FREEZE DATE**" in the Financial Aid Website.

### SEPTEMBER 2020

- MON SEP 21 **CENSUS** (Note: census is not associated with add/drop deadlines.)  
 MON SEP 21 Deadline – Last day to drop to a lower fee level and receive a refund of fees.  
 MON SEP 21 Deadline (5 p.m.) – Last day to change registered class grade option to **AUDIT**

### OCTOBER 2020

- FRI OCT 23 Spring 2021 schedule of classes available online by noon.  
 MON-FRI OCT 26 – NOV 6 **MANDATORY ADVISING** for Continuing Students – Your registration will be blocked until you meet with your advisor to talk about your DARS degree plan, academic progress, and educational goals. Your advisor will release your advising hold.  
 MON OCT 26 Deadline – **WITHDRAW (prorated refund)** Last day to request permission to withdraw from fall semester and be eligible for a prorated refund. Permission to withdraw and documentation of a serious & compelling reason are required. A grade of “W” will be recorded for each course. [After this date, students are not eligible for refund of fees.. See [withdrawal-process](#).

### NOVEMBER 2020

- MON NOV 2 Deadline: **WITHDRAW (serious & compelling reasons)** – Last day to request permission to withdraw from one, some or all courses. Permission to withdraw and documentation of a serious & compelling reason are required. A grade of “W” will be recorded for each course. [After this date, withdrawal is not allowed, except for catastrophic reasons.] See [Withdrawal Process](#).  
 MON NOV 9 **ONLINE INSTRUCTION ONLY** for the remainder of the semester  
 MON-FRI NOV 9–20 Spring 2021 **EARLY REGISTRATION** for continuing students
